- 2. 51% Black owned as defined in terms of the B-BBEE legislation
- 3. Local community based suppliers from the North West Province
- 4. Company must have practical experience of at least 3 years in the said field
- 5. Preference will be given to suppliers that own scaffolding, preferably above 1000 tons (please submit proof/confirmation of this)
- 6. Preference will be given to suppliers that have an in-house technical design team (please submit proof/confirmation of this)
- 7. Preference will be given to suppliers that are able to provide all elements of scaffolding, including hand rails, steps, platforms, etc. (please submit proof/confirmation of this)
