1. Schedule 1 Scope of Supply

The Supplier shall provide Equipment Services, which include general housekeeping and compliance maintenance on the Site.

Envisaged Start Date:	1 March 2023
Envisaged End Date:	28 February 2024
Contract Period:	12 months, with possible extension or back to back with the main employer contract.

The Supplier will be responsible for the provision of the following services at Kookfontein Site, Zizwe mining operations.

1.1. Key Deliverables

1.1.1. A CAT 428 TLB or equivalent must be dedicated on site and as provided by the Supplier for general site maintenance to ensure continued compliance.

1.2. General Site Maintenance

- 1.2.1. All housekeeping around Opencast mining areas as utilized by Zizwe must be maintained.
- 1.2.2. All other ad-hock work as a result of operational requirements will be given instruction by site supervision

1.3. General Requirements

- 1.3.1. The Supplier shall ensure that the TLB used in rendering the services is maintained in good working condition to the Mine's requirements and standards (Vehicle Standard attached) and that the Supplier shall be responsible for the cost of maintenance and repairs. The mechanic must be qualified with a valid diesel mechanic trade test, site specific PPE, valid medical, induction, mine license, minimum FRCS compliant vehicle and HSEC compliance.
- 1.3.2. The Supplier will not be entitled to remove any mobile equipment supplied to the Site, unless written permission is granted by Zizwe and the Mine.
- 1.3.3. The Supplier is responsible for their HSEC Compliance, which is bound to be above 90%.

- 1.3.4. The Supplier must provide adequate qualified/competent operators to operate the TLB and conform to the legal operating hours. One (1) operator will be required on a 10 hr day shift (06H00 18H00 Mondays to Friday (day shift only).
 - The Supplier has to ensure that a relief/stand-by operator is available for both equipment in case of leave or if an operator is absent from work. Shift schedules subject to change due to operational requirements.
- 1.3.5. Working Hours:
 - Monday to Saturday (12 hours per day, 5 days a week)
 - 06h00-18h00 only
 - Working hours may change according operational requirements.
- 1.3.6. The Supplier must have certified competent personnel issued with a certificate of Competence (COC) for the specific equipment type by an accredited service provider.
- 1.3.7. Initial medical certificate of fitness and inductions will be Zizwe's responsibility, as well as the annual renewal of the certificate (as required) and exit medical at the end of the contract.
- 1.3.8. It is the Suppliers responsibility to transport their personnel during the initial compliance period (to Medicals, inductions and training).
- 1.3.9. Zizwe is responsible for and will provide for transport to and from the site for the supplier's operators and the supplier must ensure that the operators reside along the existing transport route.
- 1.3.10. It is the supplier's responsibility to hire locally through the current existing processes that are facilitated by the main contract principal.
- 1.3.11. The Supplier is responsible to provide the site specific PPE to its personnel prior commencement of works.
- **1.3.12.** Zizwe will send a delegate to inspect equipment as it would be presented by all participants at their designated areas as part of clarification.
- 1.3.13. The equipment of the successful supplier will be inspected by the engineer from the mine prior approval to commence with works
- 1.3.14. The TLB must be strictly 4x4, not be older than 6000 hours and must have functional air conditioner.

2. Schedule 2 Price and Payment Terms

2.1 Subject to the proper completion of the Supply, Zizwe will pay the Supplier as follows:


- (a) The Supplier shall submit to the authorised Zizwe representative a progress claim after the last day of each month, or such other cut-off date as determined by Zizwe, showing in detail the amounts to which the Supplier considers to be entitled, together with all supporting documents.
- (b) The Supplier shall submit such claims and all supporting documents to the Zizwe Representative in the format as determined by Zizwe.
- (c) Zizwe shall examine the claim against the Supply as executed by the Supplier and make changes where necessary. Upon approval, the Zizwe representative shall advise the Supplier, who shall respond by issuing its Valid Invoice.
- (d) The payment is subjected to a **30 days** payment term.
- (e) The onus lies with the Supplier to ensure that the applicable payment officials of Zizwe receive the necessary documentation and valid invoices timeously.
- (f) All invoices to be submitted by the 7th day of the new month to Zizwe Site Manager of Kookfontein Site.

2.2 Contract Price

- (a) All costs must be quoted in South African Rand (ZAR) and exclude VAT.
- (b) The Supplier to ensure that adequate provision in its unit rates has been made to accommodate all such requirements and guidelines, as indicated in the Contractor's Pack and the Mine's relevant procedures.
- (c) Shortlisted finalist will undergo a thorough clarification.
- (d) The contract price will consist of four items:
 - 1. Site establishment that will be a once off cost (at commencement of contract)
 - 2. Site de-establishment that will be a once off cost (at end of contract)
 - 3. Variable rate per hour for the hourly rental cost related to every hour worked by the Equipment SMR hours will be applied. It is expected that the TLB will operate in the estimated range of 200 machine hours per month, depending on the operational requirements and the weather conditions.
