1. Schedule 1 Scope of Supply

The Supplier shall provide supply and install fence to cover the mining perimeter.

1.1 Key deliverables

The Supplier will be responsible for the provision of the following services at Boshhoek Chrome Mine Site, Zizwe mining operations.

1.1.1 Supply and install 800 Lm of 2.4m High Razor Diamond Mesh, 2 x Sets of Leaf Gates, 4.8m / Set, or

1.1.2 Supply and install 800 Lm of 2.4m High Clear View Fence, 2 x Sets of Leaf Gates, 4.8m / Set,

2. Schedule 2 Price and Payment Terms

2.1 Subject to the proper completion of the Supply, Zizwe will pay the Supplier as follows:

- (a) The Supplier shall submit to the authorised Zizwe representative their claim after completion of work.
- (b) The Supplier shall submit such claims and all supporting documents to the Zizwe Representative.
- (c) Zizwe shall examine the claim against the Supply as executed by the Supplier and make changes where necessary. Upon approval, the Zizwe representative shall advise the Supplier, who shall respond by issuing its Valid Invoice.
- (d) The payment is subjected to a **30 days** payment term upon completion of work.
- (e) The onus lies with the Supplier to ensure that the applicable payment officials of Zizwe receive the necessary documentation and valid invoices timeously.



2.2 Service Price

- (a) All costs must be quoted in South African Rand (ZAR) and exclude VAT.
- (b) Shortlisted finalist will be interviewed as part of further clarification schedules.
