As part of our community development/contribution we would like to engage the services of a subcontractor for the supply of Labour Only for the Construction of Gabion Boxes at the above-mentioned site. It would be appreciated if the invitation could be distributed through the Royal Bafokeng Administration's (RBA) network for the community to submit tenders as per scope below.

#### **1. SCOPE OF WORK**

Our contract duration is estimated at 4 months with work to commence during the week of September 2025. We will appoint a **Labour Only Sub-Contractor** for the leveling, placing of gabion boxes, lacing them, packing/filling them with suitable material as to have a fair face, installation of geomembrane as per the engineer's instructions all in accordance with SANS 1200DK. The duration of the works is 2 Months and the successful tenderer will have to start 7 days after being appointed. The Sub-Contractor will be responsible for his own tools, medical fitness certificates and PPE.

The quantities are not firm and fixed and is subject to remeasurement. There is 10% retention applicable on the contract. 50% to be paid once completion certificate is achieved and the balance after 52 weeks.
