5.7. CORRECTION OF ERRORS

5.7.1. The complete proposal should be submitted without alterations, erasures or omissions. If it is necessary to correct errors made by the Participant prior to submission, the person or persons signing the proposal shall initial such corrections in ink.

5.8. SIGNING REQUIREMENTS

- 5.8.1. Any participating entity shall comply with the following requirements;
 - a) The proposal shall be signed so as to be legally binding on the participating entity and all participating entity shareholders;
 - b) A representative shall be nominated as the authorised representative;
 - c) If participating as a consortium, the membership of each consortium member in the participating entity shall be evidenced by a duly adopted resolution of the Board of Directors or similar governing body of that member authorising membership in the consortium and copies of all such authorisations shall be included as annexure to the proposal;
 - d) No entity shall be a member of more than one consortium responding for the above project;
 - e) The responding consortium shall not change during the process or once the Participant has been nominated a successful Participant;
 - f) The authorised representative shall be the only authorised party to make legal

statements, communicate with Fraser Alexander and receive instructions for and on behalf of the participating entity;

- g) Each page of the proposal shall be initialled by the authorised representative; and
- h) All copies of correspondence from the Participant to Fraser Alexander must be signed by the authorised representative. The signature must be accompanied by the name of the person signing and the name of the Participant or the responding consortium.

 - b) Must be free from defect that affect their appearance or may affect their serviceability or both and free from stains and marks incurred during the manufacturing process.
- **6.5.4.** Business units and sites may determine additional Signage requirements to suit their own need or working conditions, in an event where the size is different from the provided list, the successful supplier will be requested to provide a quote.
- **6.5.5.** For customised Signage requests from sites, the successful supplier will be requested to provide a quote as and when needed.

7. Pricing Schedule

- 7.1. Prices to be strictly completed on the Excel Signage Specifications and Price List provided and submitted in Excel FORMAT, if provided in another format the Supplier may be disqualified. All prices per item must be all inclusive (including delivery), no separate/additional) costs will be considered.
