2. Schedule 2 Price and Payment Terms

2.1 Subject to the proper completion of the Supply, Zizwe will pay the Supplier as

- (a) The Supplier shall submit to the authorised Zizwe representative a progress claim after the last day of each month, or such other cut-off date as determined by Zizwe, showing in detail the amounts to which the Supplier considers to be entitled, together with all supporting documents.
- (b) The Supplier shall submit such claims and all supporting documents to the Zizwe Representative in the format as determined by Zizwe.
- (c) Zizwe shall examine the claim against the Supply as executed by the Supplier and make changes where necessary. Upon approval, the Zizwe representative shall advise the Supplier, who shall respond by issuing its Valid Invoice.

The payment is subjected to a **30 days** payment term.
