The Royal Bafokeng Administration (RBA) is responsible for the provision of social and infrastructural development services to the Royal Bafokeng Nation (RBN) and hereby invites tenders for the following services:

- a) Tenderers are to have a CIDB grading as indicated above or higher and will be evaluated should they submit a tender on several criteria including experience, resources, current workload, etc. Tenders who meet these and other requirements shall be considered responsive.
- b) Only Tenderers that obtain a minimum score of 68 points out of a possible 100 in terms of the defined functionality criteria will proceed to the next stage of the evaluation (See section c below). Points will be allocated for previous experience, key staff and registration with electrical contractor's bodies.
- c) Responsive tenders will be evaluated in terms of Method 2 of the CIDB evaluation criteria as follows:
 - i. Price 90 ii. Preference - 10

(The RBA only accepts certificates/grading issued by companies certified by the Association of BEE Verification Agencies)

- d) Minimum 30% Joint Venture with Local SMME registered on the Royal Bafokeng Enterprise Development database. The tenderer should include a joint venture agreement confirming the following:
 - Percentage shareholding
 - Role and responsibility of each shareholder
 - Contribution of each partner to the joint venture.
 - Letter from RBED to confirm participation on the JV agreement

The joint venture will be expected to open a joint bank account after the award of the tender.

The tender should further include a letter from the RBED which confirms that they were part of the negotiations when the joint venture was formed which is not older that 2 months from the date of the closing of the tender.

e) The Main objective of RBA is to maximise job creation, the successful tenderer will be required to utilise local skills.
