1. INTRODUCTION

The Royal Bafokeng Nation (“RBN”), administered through the Royal Bafokeng Administration (“RBA”) (RBN/A), is a traditional community-based in the Rustenburg Valley in the North West Province, South Africa. The RBN area falls within the Rustenburg Local Municipality (“RLM”) and comprises 29 villages, organised into 5 regions over a land size ranging from 1200 to 1400 km². The area is home to approximately 128 000 people according to the latest count from PULA (i.e. Population and Use of Land Audit, an independent census conducted within the RBN boundary) of those, 67% are descendants of the Bafokeng, whilst 33% are Non-Bafokeng. The RBN has properties such as Schools, Clinics, Administrative Offices, Halls, Water infrastructures, etc.

The Royal Bafokeng Nation (RBN) is seeking to establish a long-term contract for the provision of transport services to support the organisation’s operational needs on an as-needed basis. This initiative aims to ensure timely and efficient management of sourcing events, while accommodating the organisation’s evolving requirements over time.

2. BACKGROUND

The Royal Bafokeng Nation Administration (RBN/A) currently operates without a formal transportation services contract. As a result, business units must obtain quotations on an ad hoc basis, a process that is both time-consuming and administratively demanding. This fragmented approach often leads to delays in arranging transportation services, thereby affecting the organisation’s ability to respond efficiently.

To resolve this issue, the Request for Quotation (RFQ) aims to establish a long-term transportation contract that will streamline the procurement process and enhance operational efficiency.

3. OBJECTIVE OF THE BID

The objective of this bid is to appoint a service provider(s) from the Royal Bafokeng Nation to offer transportation services on a rotation basis for a period of 24 months on rotational basis.

4. SCOPE OF WORK

Transportation services are required for the specified routes, among others. Bidders should note that destinations may be subject to change. RBN/A reserves the right to renegotiate rates as and when new routes are introduced.

Performance and Legislative Requirements

- The appointed service provider(s) must be available upon request to support RBN entities, including RBA, RBS, RBI, Kitsong, RBED, and others as required.
- The appointed service provider(s) must provide RBN/A with a centralized point of contact, including the name and contact number of the responsible person for the aforementioned services.
- A minimum monthly performance level of 99% is required for vehicle arrival times at the designated locations.
- In the event that the service provider fails to meet the agreed performance target, a penalty will be applied. Specifically, a 5% deduction will be made from the invoice for the trip in which the failure occurred.
- All vehicles must be properly maintained and kept in excellent mechanical and physical condition throughout the duration of the contract.
- RBN/A will conduct a physical inspection of the vehicle prior to appointment. Subsequently, a surprise visit will be carried out from time to time to confirm vehicle's condition.
- The service provider(s) are required to appoint qualified professional drivers who possess all necessary documentation in compliance with traffic regulations and applicable legislation.

Public Liability Insurance

- Bidders must hold Public Liability Insurance with a minimum cover of Five Hundred Thousand Rand (R500,000) per incident. Proof of this insurance must be provided in the form of a valid certificate or letter from the bidder's insurance provider.
- If the bidder does not currently hold this insurance, they must submit a formal letter from their insurance provider (on official letterhead) confirming their intent to insure the bidder for the specified amount per incident.
- Should Public Liability Insurance not already be in place, the successful bidder will be required to submit valid proof of cover within two (2) weeks before a letter of appointment is issued.
- The submitted proof of insurance or confirmation letter must be dated within one (1) month of the bid closing date.
- The service provider must maintain valid and comprehensive motor vehicle insurance, including third-party liability and passenger liability coverage

Passenger Insurance Liability

- Bidders must hold Passenger Insurance Liability with a minimum cover of Ten Million Rand (R10 000 000.00) per incident. Proof of this insurance must be provided in the form of a valid certificate or letter from the bidder's insurance provider.
- If the bidder does not currently hold this insurance, they must submit a formal letter from their insurance provider (on official letterhead) confirming their intent to insure the bidder for the specified amount per incident.
- Should Passenger Liability Insurance not already be in place, the successful bidder will be required to submit valid proof of cover within two (2) weeks before a letter of appointment is issued.
- The submitted proof of insurance or confirmation letter must be dated within one (1) month of the bid closing date.

5. EVALUATION

The bid will be evaluated as follows;

- **Phase 1:** Pre-qualification.
- **Phase 2:** Administrative compliance
- **Phase 3:** Commercial - Price (80)

6.1 Phase 1 - Pre-qualification

The bidder is required to comply fully with the Pre-qualification criteria. Failure to comply with **the Pre-qualification will result in the disqualification** of the bid. The following must be submitted with the bid;

- 6.1.1 Only bidders registered with Royal Bafokeng Enterprise Development (RBED) will be eligible for consideration. Proof of registration on the RBED database must be included/submitted with the bid. A letter **not older than two months from the closing date of this bid will be acceptable.**
- 6.1.2 Bidders are required to submit a certified copy of a valid operating license permit issued by the relevant Provincial Regulatory Entity (PRE).
- 6.1.3 Bidders must have Public Liability Insurance with a minimum cover of Five Hundred Thousand Rand (R500 000.00) per incident. Proof of this insurance must be provided in the form of a valid certificate or letter from the bidder's insurance provider.

Note:

- If the bidder does not currently hold this insurance, they must submit a formal letter from their insurance provider (on their insurers official letterhead) confirming their intent to insure the bidder for the specified amount per incident.
- The submitted proof of insurance or confirmation letter must be dated **within one (1) month** of the bid closing date.

- A quote from the insurer will not suffice nor accepted by RBN/A.

6.1.4 Bidders must hold a Passenger Liability Insurance with a minimum cover of Ten Million Rand (R10 000 000.00) per incident. Proof of this insurance must be provided/submitted in the form of a valid certificate or letter from the bidder's insurance provider.

Note:

- If the bidder does not currently hold this insurance, they must submit a formal letter from their insurance provider (on their insurers official letterhead) confirming their intent to insure the bidder for the specified amount per incident.
- The submitted proof of insurance or confirmation letter must be dated **within one (1) month** of the bid closing date.
- A quote from the insurer will not suffice nor accepted by RBN/A.

6.1.5 The bidder must submit proof of their driver(s) professional Driving Permit (PrDP) assigned for the services.

6.2 Phase 2 - Administrative Compliance

The following documents should be submitted with the bid to evaluate adequately, namely;

- a) Company profile.
- b) CIPC confirmation of Company registration and Directors.
- c) Valid SARS Tax Compliance PIN.
- d) **Original and valid and / or certified** copy of B-BBEE status level certificate or sworn affidavits must be valid at the time of the closing of the RFQ.
- e) Original Bidder Resolution or Letter of authority or Letter of appointment authorizing the signatory of the Entity to sign the contract with RBA.
- f) Bank confirmation letter.

Note: Non-submission of supporting documents at the time of bid closing will not result in automatic disqualification. However, if RBN/A requests the documents and the bidder fails to provide them within the timeframe requested, the bidder will be disqualified from the bidding process.

In the case of the BBBEE certificate or sworn affidavit, failure to submit at the time of bid closing will not lead to disqualification. However, the bidder will receive zero (0) points for the preferential scoring criteria applicable to the project.

6.3 Phase 3 - Pricing Schedule
